Guidelines for the Submission of Abstracts and Full Papers

- The maximum word limit for an abstract along with 4-6 key-words should not more than 400 words. Title of the paper, full name(s), affiliation(s), email address and phone number(s) of all the author(s) should be mentioned.
- Full papers should be submitted in usual standard format electronically preferably within 3500 words.
- Papers should be typed (1.5 spaced) in A4 size paper, Times New Roman, font size 12 (14 for heading).
